Amend Section 2649 as follows:

**2649. Fees.**

The fees for landscape architect applicants and landscape architect licensees shall be fixed by the board as follows:

(a) The application fee for reviewing an applicant's eligibility to take any section of the examination, commencing with the 1999 examination and thereafter, is \$35.

- (i) The fee for a red line review is \$100.
